



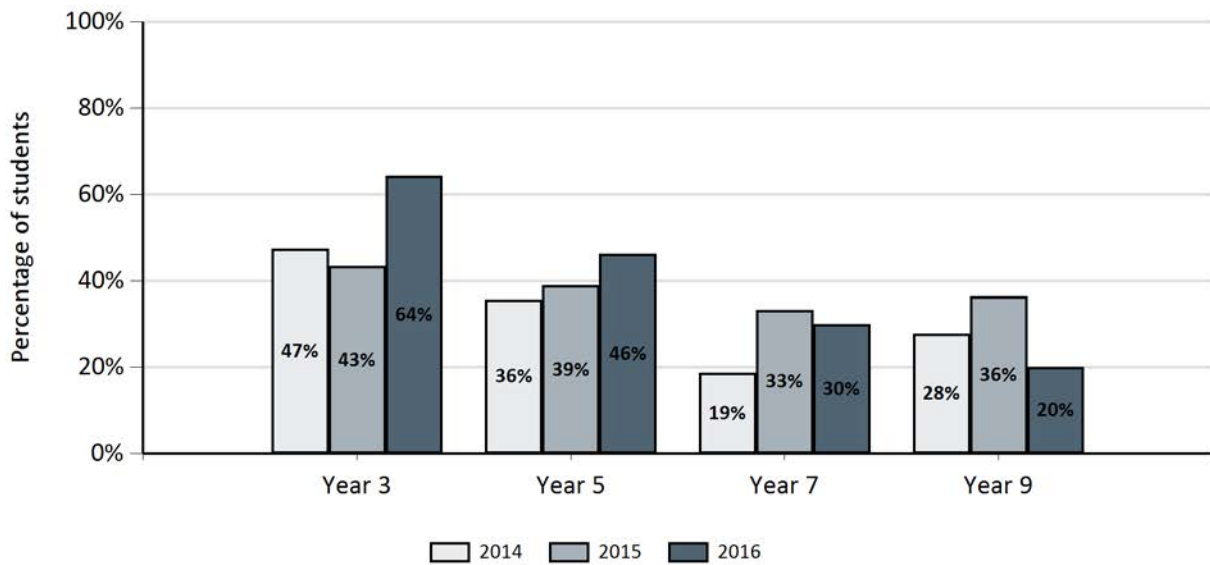

NAPLAN Proficiency

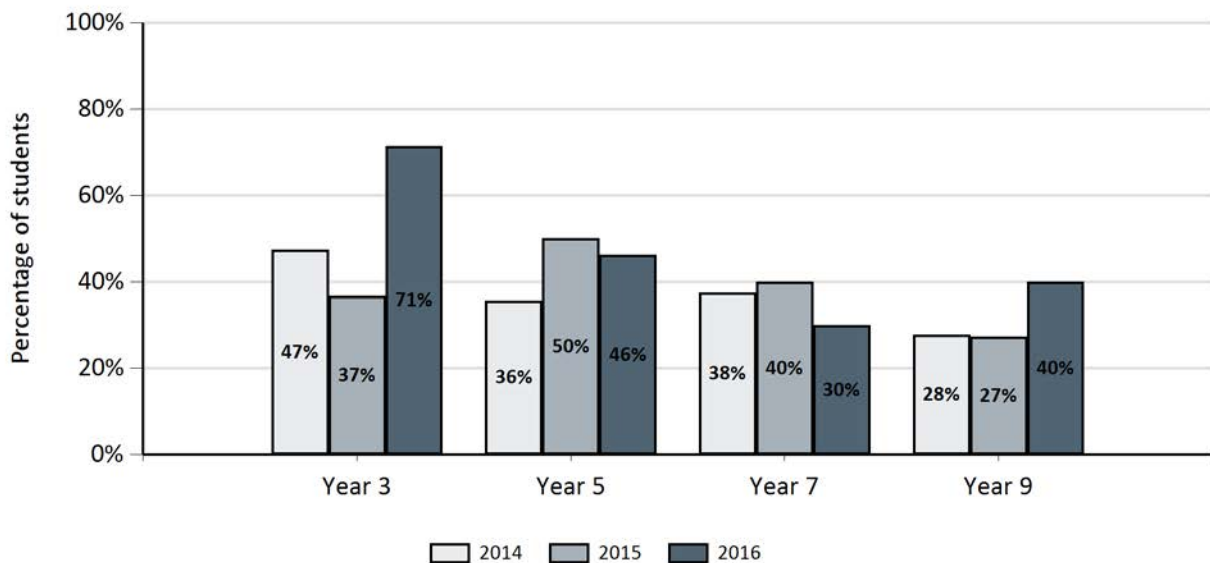
